New Article-Based Continuing Certification (ABCC) Pathway Enrollment opens to Diplomates in November

The ABPN is excited to announce that enrollment in the new ABCC Pathway for continuing certification will be available to all diplomates with active certificate(s) in 3-year blocks beginning **November 15, 2021**.

The ABCC Pathway is an ongoing professional journal article-based assessment activity designed as an optional alternative to the current traditional 10-year recertification/CC examination.

From **November 15 through December 31, 2021**, diplomates will be able to view individualized ABCC Pathway article assessment requirements and enroll in the pathway through their <u>Physician Portal/Folios</u> account.

If no assessment pathway has been chosen by **January 1, 2022**, the ABCC Pathway will become the automatic default assessment option for diplomates with eligible active certificate(s) in 3-year blocks. Beginning on **January 15**, **2022**, the ABCC article assessments can be accessed through the secure, newly designed ABPN Physician Portal.

Diplomates with 10-year certificates (expiring in 2022), non-time limited (Lifetime) certificates, and lapsed certificates will need to wait until early 2022 to apply for the article assessment pathway.

ABPN Launches New Physician Portal

ABPN has launched a new and improved version of Physician Folios. The new <u>Physician Portal</u> interface features an easyto-follow dashboard approach to personalized Continuing Certification (CC) Program requirements and deadlines.



Diplomates also can use the new Physician Portal to access ABPN's new <u>Article-Based Continuing Certification</u> article assessments beginning on **January 15, 2022**.

3-year CC Block Reset

Beginning **January 1, 2022**, the new Physician Portal will reset all active 3year CC blocks with the years 2022-2024 to align article assessment and CC requirement completion deadlines. Any CC activities completed and attested to during the current CC block will be credited towards the 2022-2024 block, including CME, Self-Assessment, PIP, and Pilot article exams, if applicable.

Annual Fee Format Changes

Beginning in 2022, the annual CC fee amount will be calculated based on the number of active certificates: \$175 for one certification; \$300 for two certifications; \$395 for three+ certifications. The annual fee will cover either assessment pathway (ABCC or Exams) for all certificates in the CC program. Diplomates will no longer be required to submit a traditional recertification application and payment provided their certification(s) remain active.

Additional CME Offerings from Select Subspecialty Societies for ABPN Diplomates

The ABPN has announced that all ABPN diplomates, regardless of areas of subspecialty certification or society membership, will have access in 2021-22 to additional self-assessment and CME options from select professional societies at either typical member pricing or at no cost.

Through unrestricted educational grants from the ABPN, the following societies have posted or will post information on how diplomates can access activities to earn additional credits:

ABMS Supports Role of Medical Professionals in Preventing COVID-19 Misinformation


The American Board of Medical Specialties (ABMS) announced recently it is committed to preventing the spread of misinformation about
