CEO videos: How to *Not* Peak at the End of Training: Lifelong Learning and ABPN Certification

ABPN President and CEO Dr. Jeffrey Lyness recorded <u>two brief videos</u> as an educational offering for trainees and training program directors that can act as springboards for group discussion about lifelong learning, including the challenges and rewards of maintaining and developing one's specialty or subspecialty expertise in the years after completing formal training.

The videos focus on how to continue professional development after completing residency or fellowship training, and how specialty board certification fits into the landscape of lifelong learning. Physicians in practice also may find these videos useful to inform self-reflection or group discussions about lifelong learning in the context of ongoing careers.

ABCC Article Exam Sharing Policy

While diplomates are welcome to discuss the articles in a journal club or similar format, discussing the questions and answers of an exam is strictly prohibited by the ABPN and would be considered irregular behavior according to ABPN's policies.

Diplomates are required to complete exams independently. The ABPN prohibits consulting other people on the content of exam questions, sharing the questions or their answers, or discussing the questions in a group setting. This prohibition also precludes using 'answer keys' prepared by others or artificial intelligence applications to answer the questions. All of these approaches would constitute <u>irregular behavior</u> (i.e. cheating) and would accordingly be subject to action by the ABPN. Before taking each article exam, diplomates are asked to attest that they have not shared or discussed the questions or answers.

2024 Deadline for Continuing Certification (CC) Article Exams

All Continuing Certification (CC) Program requirements are represented in the Physician Portal in ongoing three-year blocks based on your year of board certification/recertification. Personalized CME, Self-Assessment, PIP, and article exam progress can be viewed in the <u>Physician Portal</u>.

Diplomates with active CC certificates in the 2022-2024 three-year block need to successfully complete article exams by **December 15, 2024**, to have them count in lieu of your next scheduled recertification examination. Diplomates with either activities or assessments due at the end of 2024 recently received

an email reminder directing them to their Physician Portal to see what requirements remain for them.

The CC program is an ongoing process, so board certification does not have a specific end date. Board certification status is contingent on meeting all CC requirements, which are largely grouped into three-year CC cycles, as outlined in the graphic below.

If you do not successfully complete the article exams by the due date in your Physician Portal, or if you are enrolled in the exam pathway rather than the ABCC pathway, you will need to pass the traditional CC/recertification exam by your exam due date shown in your Physician Portal in order to maintain certification. For those who successfully participate in ABCC from 2022-2024, the ABPN will waive 16 out of the 24 Self-Assessment (SA) CME credits for the current 3-year block at the end of 2024. NDD Credentialing Requirements Change

Before submitting an application for certification in neurodevelopmental disabilities, an applicant must be certified by the ABPN in neurology with special qualification in child neurology by December 31st of the year prior to the examination administration. Beginning in 2024, there is no longer an ABPN requirement to be certified by the American Board of Pediatrics. At their discretion and their program's discretion, applicants may or may not have

chosen to do pediatrics rotations that make them eligible for certification in pediatrics.

March 1 Annual Reverification Date of Certification for Credentialers

The ABPN recognizes that some entities, e.g., hospital medical staff offices, may still require a certification end date to complete verification. To assist in this process, we encourage credentialers <u>to utilize an annual reverification date</u> <u>of March 1 in any given year</u>. Please note, this date is not necessarily reflective of individual CC requirements, nor does it indicate certification or CC cycle end dates.

c) self-nominations from ABPN-certified physicians.

2024 ABPN Board of Directors Announced

The ABPN recently announced its 2024 Board of Directors. The Board's term runs through December 2024.





Dr. Steven Lewis was named chair from January through June. Dr. Lewis is the Physician in Chief and Chief of Neurology at the Lehigh Valley Fleming Neuroscience Institute at Lehigh Valley Health Network in Allentown, PA, where he holds the Timothy M. Breidegam Endowed Chair in Neurology. He is also the liaison to the United Council for Neurologic Subspecialties and the American Stroke Association.



Dr. Nina Schor was named chair from July through December. Dr. Schor is currently the Deputy Director for Intramural Research of the National Institutes of Health. For five years, she served as the Deputy Director of the National Institute of Neurological Disorders and Stroke; for 11 years she served as Chair of the Department of Pediatrics at the University of Rochester and Pediatrician-in-Chief of its Golisano Children's Hospital.

Christopher R. Thomas was named Vice Chair. Dr. Thomas is Professor Emeritus of Psychiatry at the University of Texas Medical Branch. He was a Regent of the American College of Psychiatrists in 2019 - 2023 and he is an Associate Editor for the *Journal of Graduate Medical Education*. He was previously Chair of the Accreditation Council for Graduate Medical Education (ACGME) Psychiatry Review Committee and the ACGME Psychiatry Milestones Committee.

Email Security Best Practices - Be Alert About Phishing Emails

Email phishing is a fraudulent way for computer hackers to spoof people into giving up personal data. Hackers send messages that appear legitimate or look like they're from someone you trust so that you engage with the message or click on malicious attachments.

Here are some tips to keep in mind to avoid falling victim to email phishing:

- Double-check that the sender's email address matches who they claim to be
- Don't click a link or download from someone you don't know, or weren't expecting
- Don't reply to a suspicious email or message from an email you don't recognize

The ABPN does not, under any circumstances, contact diplomates directly to request personal or sensitive information via telephone, email, or text messages. This includes, but is not limited to, information such as social security numbers, financial account details, or login credentials.
